

#### SELF ADVOCACY CORNER



The Arc Quinebaug Valley Self Advocate Coordinator Jamie Lazaroff writes each issue on his latest activities.

In September I had the pleasure of giving the keynote address at the People First of West Virginia 3 day conference. About 280 Self Advocates from around West Virginia attended this conference to learn self advocacy and self determination.

I traveled in on Tuesday to Parkersburg to rest up for the big day on Wednesday. On Wednesday, we traveled down to the conference at the state 4H camp called Jackson's Mill in the small town of Jane Lew. I gave the keynote on Wednesday at the opening ceremony. I talked about self advocacy and why speaking up for yourself is important, using some of my personal experiences to reflect upon.

My speech was followed up with a question and answer session and the self advocates in the audience were truly engaged with much enthusiasm. I was very impressed with their appetite for knowledge and information.

On Thursday, I co-presented a workshop on "How to Interview" for television or radio that was very interactive, including role playing with people in the group. The rest of the day was for leisure time, a candidate forum and other workshops and activities such as arts and crafts, games, etc. The end of the day was their banquet and dance. Friday was closing ceremonies which included recognition and awards for who stood out as leaders in the self advocacy movement around the state. I also got the chance to thank them for their warm hospitality and congratulate the People First members for their vision and conducting a successful conference.

In all my years of self advocacy and all the conferences I have attended, this was one of the best and most well-organized. I brought back lots of information and ideas to help our self advocate group here in Connecticut grow. We also plan to start a youth self advocacy group in the near future.

One of the slogans I liked was "If you're not at the table, you're on the menu."
